Our interns engage in 30 to 40 hours a week of service-learning while performing a variety of farm chores including gardening, feeding, socializing, and exercising farm and domestic animals, mucking out the barn, moving irrigation pipes, and other farm chores as needed. Are you willing and able to accomplish these volunteer tasks?			
Our interns engage in hard, physical volunteering and thus our intern program is only suitable for people who are physically fit and able to work outdoors in all sorts of weather conditions. Are you physically and mentally prepared for this challenge?			
Our interns need to be self-motivated, dependable, a team player, and flexible about what kind of volunteer task he or she is assigned to perform on a daily basis. Do you possess these qualities?			
Sanctuary One can provide intern housing which includes a bathroom/shower, a shared country kitchen, dining room and living room. Living quarters vary depending on time of year and how many other interns reside at the farm. Opions include a private room or shared dorm-style room. Are you willing to accept whatever housing is available?			
We require a \$50 refundable cleaning deposit to be paid in cash upon arrival. It will be held in the Sanctuary safe until you check out at the end of your stay. Please initial to agree:			
Volunteering as an intern at Sanctuary One does not create a landlord/tenant relationship. An individual is granted permission to live at the Sanctuary only as long as they remain in "good standing" as an intern. If the intern relationship is terminated by Sanctuary One, the individual must vacate the property as soon as reasonably possibly, and in no event longer than 48 hours.
