There was some sad news last week out of **Sanctuary One**, an animal rescue farm/ranch located outside Ruch. **Lulu**, their "senior ambassador pig," passed away in her sleep on Mother's Day. She would have been ten years old this month. She followed Lisa, the operation's first ambassador, who passed away at the age of eight in 2015.

"Lulu came to us from Pigs Peace Sanctuary in August 2010 at three months old, after being rescued from a factory farm," said Executive Director **Megan Flowers**. "Over the years at the farm she has enjoyed running in the field, being queen of the mud wallows, bossing her Sanctuary One brothers around, getting spoiled with food from natural grocers, and sitting for treats. Everyone at Sanctuary One appreciates those who have provided her with a good life through your donations, and for all our guests who have gotten to know her while on the farm. We are thankful Lulu came into our lives and hearts."

Sanctuary One will continue to fundraise for the pig habitat in her honor and for future senior pigs, as the new location will increase their quality

of life as they age. They will be naming her side of the building in her honor, as she was the inspiration for the project.
